The information is drawn from Recommendation 2/2001, which the European data protection authorities of the Working Party established by art. 29 of Directive 95/46/CE adopted on May 17th, 2001 with the aim of determining some minimum requirements for collecting personal data on-line and, in particular, how, when and what information the controllers are obliged to supply the users when they connect to Webpages, independently of the purpose of the connection.

DATA CONTROLLER

As a result of consulting this Website, data concerning identified or identifiable persons may be processed. The data controller is **Geovita® S.r.l.** based in Corso Barolo, 47 - 12051 Alba (CN) - Italy and VAT number 03060290040.

WHERE DOES DATA CONTROL TAKE PLACE?

Data control related to this Website's web services takes place in the aforementioned office of **Geovita® S.r.l.** and only technical staff or staff in charge of occasional maintenance attend to it. No data deriving from the web service is disclosed. Personal data provided from users forwarding requests of information material (e.g. newsletters, etc.) is only used to execute the required service or performance.

DATA CONTROLLED

Online browsing data

The computer systems and software procedures deployed to run this Website acquire, while working, some personal data whose transmission is implicit in the communication protocols of the Internet. This kind of information is not collected to be associated with specific individuals but, by its own nature, it might allow to identify users through processing of and association with data collected by third parties. In this data category are included all IP addresses or domain names of computers used by users connecting to the Website, URI addresses (*Uniform Resource Identifier*) of the requested resources, the time of the requests, the way the requests were submitted to the server, the size of the files obtained in reply, the numerical codes indicating the status of the responses from the server (successful, error, etc.) and other parameters related to the operating system and the users' system environment. This data is deployed with the sole purpose of obtaining anonymous statistical information on the use of the Website and to monitor its proper functioning. The data might be used to verify responsibility in case of hypothetical cybercrime at the expense of the Website upon request from the designated surveillance bodies.

Data voluntarily supplied from the users

The optional, explicit and voluntary forwarding of electronic mail to the addresses displayed on this Website implies consequent acquisition of the senders' address, necessary in order to reply to his/her questions, and any other personal data contained in the message.

Cookies

No users' personal data is acquired on purpose by the Website. No cookies are used for the transmission of personal information, nor is any kind of persistent cookie used, such as users tracking systems. The deployment of session cookies (not stored persistently on the users' computers and deleted when the browser is closed) is strictly limited to the transmission of session identifiers (made of casual numbers generated from the server). These are necessary to allow a safe and efficient browsing of the site. The session cookies used in this Website avoid recurring to other IT technologies potentially affecting the users' browsing privacy and do not allow to acquire users' personal identifying data.

OPTIONAL DATA SUPPLY

Except for what concerns browsing data, users are free to supply personal data in the request forms to **Geovita® S.r.l.** or while contacting the company to request informative materials or other communications. The lack of this data might prevent the users from obtaining what they requested.

MINORS

No person under the age of 18 may forward information to this Website without previous consent from his/her parents or legal guardian, nor may he/she make purchases or execute legal acts without such consent, unless it is allowed by the current regulations.

CONTROL

Personal data is controlled via automated instruments for the time strictly necessary to achieve the purposes for which it is collected. Specific safety measures are adopted to prevent data from being lost or used in an illegal or incorrect way and to avoid unauthorized access.

USER RIGHTS

Individuals to whom personal data refers have the right to require a confirmation of the existence of said data and to know its content and origin, to verify its correctness or to request its integration, update or correction at any time (art. 7 Legislative Decree no. 196/2003). According to the same article, they also have the right to require cancellation of the aforementioned data, its conversion into anonymous data or the block of the illicitly controlled data, as well as to oppose to its control for legitimate reasons.
